O administrador judicial abriu a oportunidade à comunidade de credores se havia interesse entre eles em secretariar os trabalhos, não houve interesse, sendo nomeada como secretaria Daniely Heloise Toledo, portadora do RG 5099090-7 SSP/PR, cumprindo os termos do artigo 37 da Lei 11.101/2005.

Determinou o presidente da Assembleia seja registrado que o credor Perficampo Industria e Comercio Ltda – EPP possui um crédito de R\$ 21.220,92 (vinte e um mil, duzentos e vinte reais e noventa e dois centavos), pertencente a Classe III, por um erro material constou no Edital Geral de Credor (2º Edital) em duplicidade. Portanto, na composição dos interesses dos credores registra-se para que não ocorra nenhuma divergência em votação, ficando re-ratificado neste ato o aqui disposto.

Conferidas as presenças, em livro próprio, constatou-se a seguinte proporção de créditos presentes:

**89,39%** dos credores quirografários que equivale a **R\$ 34.021.583,62** dos créditos;

**100%** dos credores garantia real que equivale a **R\$ 35.131.239,77** dos créditos;

**39,90%** dos credores da classe trabalhista que equivale a **R\$ 854.957,74** dos créditos;


**100%** dos credores Micro Empresa e Empresa de Pequeno Porte (EPP) que equivale a **R\$ 97.782,11** dos créditos.

Diante da ausência de quórum na classe I - Trabalhista, pois não foi atingindo o percentual de exigência legal, contido no artigo 37, parágrafo 2º da Lei 11.101/2005, não sendo possível, portanto, a instalação da Assembleia Geral.


